On January 9, 2017, Glenda Farnden, the Municipal Relations Liaison with the STARS Foundation made a presentation to Town Council giving an overview of the STARS equipment and financial position.

As part of the presentation Glenda requested that Council consider a \$2.00 per capita donation to the STARS Foundation to ensure the sustainability of these emergency services. The level of support has been adopted by several other municipalities previously.

The cost to the Town of Vulcan to contribute at the suggested level would equal \$3,672.00.

Council could contribute to the STARS Foundation with a one-time grant to an organization through Policy F-45 or could consider contributing annually by adding the STARS Foundation to Policy F-26 Recurring Grants to Organizations.

11.4 Twin Valley Regional Water Commission 2017 Budget Changes

The Twin Valley Regional Water Commission requisitions funds from its members for the annual operations and debt repayment of its assets. Since the formation of the Commission this funding formula has been established as part the member approved Business Plan that was put in place in 2011. The Water Commission has provided the attached letter outlining changes they have approved as part of their 2017 budget process.

On January 4, 2017 Administration received a copy of the Water Commissions budget, which was approved by the board on November 29, 2016. In reviewing this document there were two significant changes in the water commission budget that were not brought forward to Town Council for discussion or input.

The first change was a rate increase for water from \$1.71 to \$1.75 per cubic meter, this amounts to a \$16,000.00 increase to the Town budget and is needed for commission operations.

The second change is with the debt repayment percentages. The commission has changed the Town rate from 72.5% to 80.1%, this amounts to an additional \$5,973.12 to the existing loans. When added to the newest loan taken by the commission, it has increased the Town's contribution to a total of \$13,606.21 that was not included in the Town's budget.

Councillor John Seaman requested that this discussion be moved in-camera for the purpose of a legal matter for further discussion.
